(57) Abstract :

The present invention discloses a method for development of quantification model through a score weightage. The method includes of arranging a set of questions in order to seek opinions of samples; reflecting scores based on observation, response from executives and workers to the factors reflecting QWL, wherein non existence of such activities carried no marks to the particular factor or category and the same is mark for the absence of the management™s perception about the QWL factors; facilitating more than two options to answer or note down the response to question in that case complete positive response gets considered to assign the score because complete positive response only is the true representation of QWL factor, wherein besides assignment of score, there is a scheme for negative marking also; applying negative marking only on those factors, which are basic things, the needs of any employee in the work, wherein non existence of activity or any unsatisfactory conditions carry negative score; rating the every sample unit with the help of the score weightage method; and converting actual scores of the samples into qualitative grades according to ranges of total scores obtained.
